- 3) is not a resident of the county or zip code areas where summoned to serve (King County, 98155 or 98028)
- 4) is not able to communicate in the English language
- 5) if convicted of a felony, has not had his/her civil rights restored

If you have a **valid excuse**, as specified above, STOP here. Return this form in the enclosed envelope within seven (7) days of receipt.

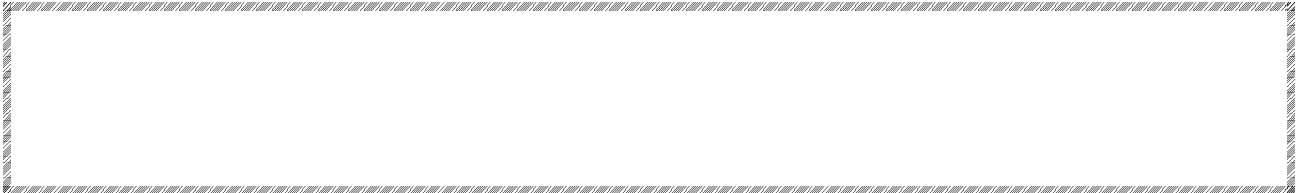
