Proposal: Replace an existing storm culvert with a partial fish barrier 96"x76" elliptical structural steel culvert including a new 70-foot long fish passable pre-cast concrete box culvert and wing walls. Remove 5 trees within surrounding critical areas.

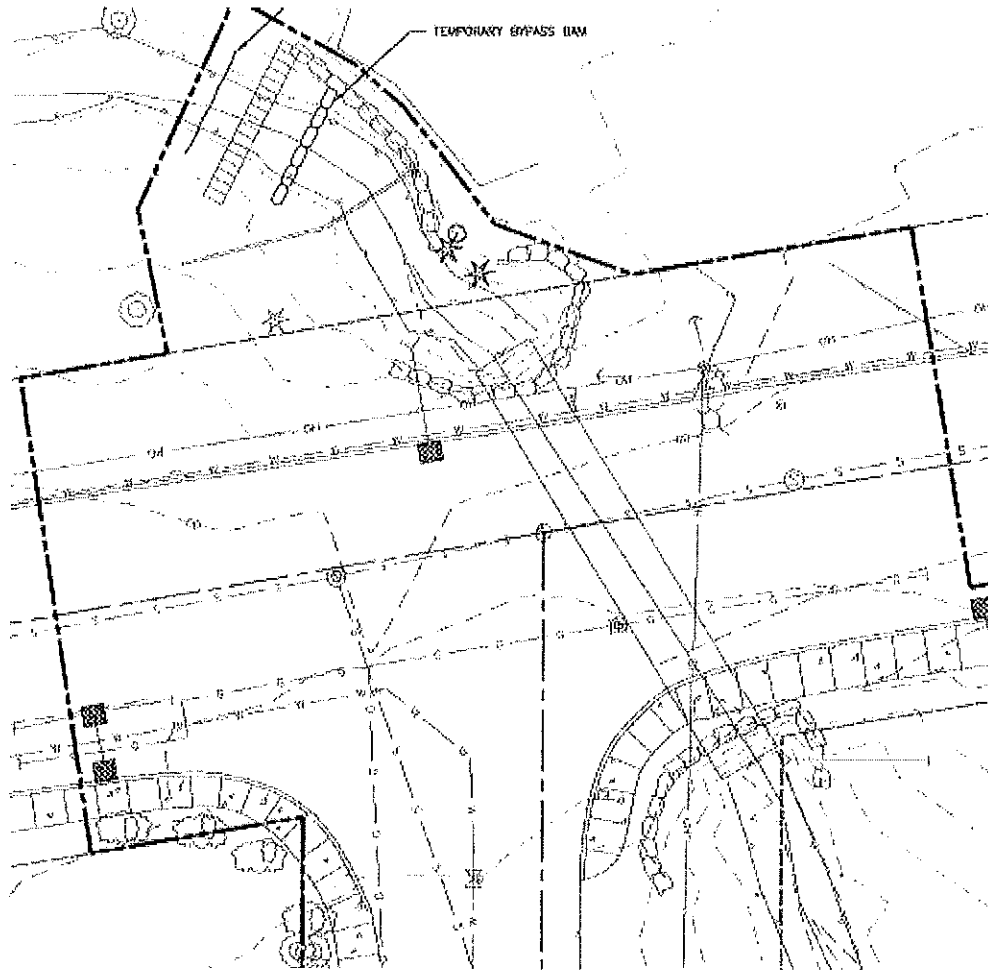
